TERMS – CCS PARK

This form must reach the organiser duly completed, signed and dated.

Payment terms

The registration fee (non-refundable) must be paid when the order is confirmed. An invoice for the amount will be issued by the organiser.

The stand fee will be invoiced as follows:

50 per cent of the fee for the ordered stand space will be invoiced in the autumn of 2009. No stand space will be allocated unless 50 per cent of the fee for the ordered space has been paid. Exhibitors placing new orders after 1 January 2010 will be invoiced for the registration fee and the full stand fee directly. An invoice for the amount due will be issued and sent to the exhibiting company directly.

If the invoice is not settled in accordance with the payment terms specified above, the organiser reserves the right to allocate the space concerned to other exhibitors.

Cancellation terms

Exhibitors who withdraw or reduce the amount of space originally ordered or transfer to another group stand will be liable for the stand fees as originally booked in accordance with the following scale:

- Cancellation or reduction between 1 January 2010 and 1 April 2010: 50 per cent of the total stand fee.
- Cancellation or reduction after 1 April 2010 – no refund given.
- No part of the registration fee will be refunded.

NB! Any reduction in the stand area must be agreed with the organiser.

The organiser reserves the right to close registrations or reduce the area requested if the exhibition is fully subscribed. Without having to state reasons, the organiser can also refuse applications or objects for exhibition, and adjust or possibly reduce the area requested.

Exhibition space may not be sub-let.

Technical regulations

The exhibitor undertakes to study carefully and observe the technical regulations, which will be sent to each exhibitor's contact person.

Breach of contract

Should one of the parties be responsible for significant breaches to the terms of this contract, the other party can cancel the contract with the party in breach with immediate effect and without prior notice.

Disputes

The parties nominate the Stavanger City Court (Stavanger Byrett) as the conciliation board in the event of disputes over this contract.
